



SOCIAL POLICY DISCUSSION PAPER

In October 2009 For the Sake of Our Children Trust hosted three collaborative meetings with leadership representation from over 18 organisations from the community, health, education, government and business sectors.

These individuals recognised the need to initiate dialogue with key leaders across the community and felt it important to hear views on the state of our families and the wellbeing of our children in New Zealand.

The general consensus across all three meetings was the need for New Zealanders to:

- ❖ *Uphold the family unit; married mother and father raising their children*
- ❖ *Review and overhaul many of the failed social policy initiatives that have simply not been effective for families and children.*
- ❖ *Build stronger partnerships between central government, local government and communities; and*
- ❖ *Continue to work collaboratively towards leaving a positive legacy for our children.*

Our dialogue brought about an in-depth discussion on our collective hope of leaving a safe and great legacy for our children. It was concluded there needed to be a strong family unit of a mother, father and a loving environment necessary to a child's development and learning.

It was agreed that extra emphasis needs to be given to the Maori and Pacific communities. These communities remain over represented in many adverse social areas; overcrowded housing, student truancy, high crime rates, and welfare dependency, resulting in many children being raised in highly unsatisfactory environments.

Aspirational Statements on: Marriage, Family, Parenting and Government

Below the group collaboratively discussed the Aspirational statements to what would be the best ideal situation for our children and the future legacy we hope to leave them. Without placing judgement on other family models that exist, this is what was agreed upon being the best for our children.

Parenting– As research points to a significant improved prospect for married couples;

- ❖ To nurture and provide a safe environment and economic stability and,
- ❖ To provide the opportunities for a child to grow up to be a good citizen;
- ❖ Parents ideally should commit to each other in marriage and commit to their responsibilities when raising a child.

The general consensus discussed and agreed upon regarding the obligation and responsibility of parents to their children is

*“The primary obligation and responsibility of the Parents is to RAISE the child.
However, this responsibility should not be in isolation but should come with the support of the community and, to some extent, the Government.*”

Family– The common suggestion that came from the groups of leaders is the need for the family unit to be one that is solid and clearly defined.

“A strong family unit to raise a child should ideally consist of a married father and a mother who will do everything they can do to raise, protect and love their children”

Government/Local Government

“We recognise the need and civic responsibility between the government, local government, local communities and the extended families to support the family unit – married parents and the child/children”.
